

# FAMILY SUPPORT VS K-PLAN AND OTHER SERVICES

## Family Support

**Private insurance, No Medicaid or refuse K-plan**

**Max Total of \$1,200.00 per year.** Spent flexible via the individual's needs. **State Funds are NOT guaranteed.** Service dollars must be approved by the Service Coordinator (SC) prior to the services provided.

- ✓ Community Inclusion (groups/ camps/ sports registration costs etc. up to \$150.00)
- ✓ Environmental Accessibility Adaptations (up to \$500.00)\*
- ✓ Family Training
- ✓ In-home daily/ Respite Care (hourly or overnight)
  - **Can only use a private provider aka Personal Support Worker (PSW)-** Can be used for Camps of all kinds.
- ✓ Specialized Diets (up to \$50.00 per month)\*
- ✓ Specialized Equipment and supplies (up to \$500.00)\*
- ✓ Transportation (rural only)
- ✓ Specialized Consultation-Behavior consultation and Nursing Delegation

## Personal Care 20 Hours

**Must have Medicaid Cannot use PMDDT**

- ✓ PC-20 can be added on to Family Support if K-Plan is refused and **MUST** have already existing Medicaid coding.
  - **Can only use a private provider aka Personal Support Worker (PSW).**

## K-Plan

**Must have Medicaid or PMDDT**

**No max hours per year. Hours are based on Child Needs Assessment (CNA).** Other services do not affect the monthly hours. If CNA hours are lower than 20, we can do an exceptions request.

- ✓ Assistive devices (up to \$500.00)\*
- ✓ Assistive Technology (up to \$500.00)\*
- ✓ Attendant Care (hours based on CNA)- Can be used for Camps set up with the state.
  - **Can use a private provider OR provider Agency. All PSW's must be over 18 and able to pass a back ground check.**
- ✓ Behavior Support (27-30 hours for assessment and behavior support plan)
- ✓ Community Nursing (referred)
- ✓ Environmental Modifications (up to \$5,000.00)\*
- ✓ 14 days Relief care (24 hours not to exceed 7 days consecutive) Can be used for Camps set up with the state.
- ✓ Skills Training (uses Attendant Care hours)

## Waiver Services

**Need SSI or PMDDT through K-Plan**

- ✓ Family Training (up to \$250.00 per event)
- ✓ Specialized Diets\*
- ✓ Environmental Safety Modifications (up to \$5,000.00 per year)\*
- ✓ Vehicle Modifications (up to \$5,000.00 per year)\*
- ✓ Specialized Supplies\* (ie: Wipes)

## MUST BE 18:

- Job Coaching
- Job development
- Small Group Supportive Employment
- Discovery

\*Requires a denial letter from insurance.

## NOTE

- If you have private insurance and no Medicaid, your child can apply for Medicaid via a PMDDT. Your SC will assist you. This can take around 90 days to process.
- Potential PSW's must be at least 18, able to work in the US, complete a new application packet and background check. This can take around 6 weeks to process. PSW will require to have an email.
